## **PARENT AND CAMPER AGREEMENT:**

I am the parent or legal guardian of the Child named on this application. I agree to support the final decision of the directors in their cabin assignment of my daughter. I give permission for photographs and video footage of My Child to be used by the camp for promotional or other reasonable business purposes. It is understood that, if accepted, camp fees are: \$1,950 Junior Camp; \$5,600 June Camp; \$8,650 Main Camp; \$3,950 Aug. Camp. I agree to follow the payment schedule, and have my balance paid in full by February 1<sup>st</sup>. I agree to complete my required camp forms by May 1<sup>st</sup> (turned on March 1<sup>st</sup>). I agree that if My Child is dismissed from camp for violation of the rules, regulations or instructions of a counselor or employee, I will not receive any refund of camp fees.

I am familiar with Camp Greystone's programs as described through printed materials, videos, and the website. I have also had ample opportunity to ask questions about Camp Greystone activities and associated risks. I understand the risks associated with attending Camp Greystone and participating in its activities include those associated with various locations and equipment, such as boating; motor vehicle travel; exposure to the elements of nature (including heat, cold, rain and lightning); sports and other recreation; water sports; and horseback riding and other animal encounters (including falls, kicks, and bites). I acknowledge that camp activities include travel off Camp Greystone's premises to recreational opportunities and that as a camper, My Child will have access to fire; ovens and stoves; waterfalls, lakes, and rivers; rugged rocky and wooded terrain; rock cliffs; and potentially harmful plants, snakes, and other creatures. I acknowledge and affirm that due to the nature of the activities and Camp Greystone operations, despite the exercise of reasonable care by Camp Greystone employees and campers, there remain risks that can result in loss or damage to property and to My Child, including accidental injury, illness, permanent trauma, disability, or death.

If my daughter is accepted, she will conform to and adhere by the rules and regulations of Camp Greystone. She and I both understand that campers are prohibited from bringing the following to camp: cell phones or other electronic devices, food, gum, slime, valuables (including irreplaceable or expensive clothing), alcohol, illegal drugs (including prescription medication not prescribed to My Child or otherwise used differently than prescribed), tobacco or tobacco products (including electronic and vaping devices, e-cigarettes, JUULs, or any smoking or vaping devices or paraphernalia), weapons, lighters, matches, explosives, fireworks, clothing with inappropriate or offensive images or messages, pets or other animals, personal vehicles or any other item Camp Greystone deems unsafe or unacceptable.

She and I both understand that possession of any of the listed items or any other items that Greystone deems unsafe or unacceptable will result in immediate dismissal. If I have any questions regarding whether a particular item is acceptable, I will ask a Camp Greystone employee and abide by their decision. I agree that My Child may not engage in stealing, bullying, or other conduct disruptive to the camp community (as determined in Camp Greystone's sole discretion). Campers are not allowed to take pictures of any girls in the shower, changing areas, or while anyone is not fully clothed. Camp Greystone reserves the right to conduct searches of its property, as well as all property and possessions that My Child brings to camp, at any time. My Child's possessions and person are subject to search at any time without further notice. My Child's safety and the safety of others depend on her following these rules and the instructions provided by Camp Greystone counselors and other employees. My Child has no reasonable expectation of privacy in any Camp Greystone property or in any property, belongings, or other items that she brings to camp.

Further, in consideration of the privilege of My Child's voluntary participation in Camp Greystone, intending to be legally bound, I hereby promise to waive for myself, My Child, and our guardians, heirs, executors, administrators, legal representatives and any other persons on my own behalf and on behalf of My Child, any and all rights and claims for damages, demands, and any other actions whatsoever, including those attributable to simple negligence, which My Child or I may have against Camp Greystone or any of its owners, directors, counselors, agents, or employees (collectively, the "Released Parties"), which said injuries arise out of My Child's or my own participation in Camp Greystone. I acknowledge that I have full knowledge of the risks associated with attending Camp Greystone and participating in its activities. I expressly, knowingly, and voluntarily assume the risks involved in My Child's attending Camp Greystone and participating in its activities. I hereby agree to hold the Released Parties harmless for any injury My Child or I sustain while attending Camp Greystone or participating in its activities. I understand that this assumption of risk agreement remains in effect until notice of cancellation is received by Camp Greystone. I hereby expressly waive and release any and all claims, now known or hereafter known, whether arising out of the negligence of the Released Parties or otherwise. I covenant not to make or bring any such claim against any of the Released Parties, and forever release and discharge Released Parties from liability under such claims. I understand that My Child will not be permitted to attend Camp Greystone without providing this waiver and release.

I hereby authorize any member of Camp Greystone's staff, including but not limited to any Camp Director, any Camp medical personnel, and any Camp Counselor to consent to medical treatment for My Child as they deem to be in the best interest of My Child on any occasion when prompt treatment is recommended by a medical professional and I am unavailable to consent to such treatment or otherwise in the event of a medical emergency. I represent that the attached Medical Treatment Information Form is complete and accurate, and I will provide any updates to the information on that form to Camp Greystone within a reasonable time period.

I further agree that any dispute or complaint My Child or I may have against the Released Parties is governed by the laws of North Carolina, and any mediation or suit regarding those claims must be brought in Henderson County, North Carolina.

By entering my signature below, I acknowledge that I have read and understood all the terms of this Agreement and that I am voluntarily giving up substantial legal rights, including the right to sue Camp Greystone and the other Released Parties.
